Member-Get-Member (MGM) 2.0 Promo

1. Citibank cardholders (referred to as “Referrer”) will get a Php3,000 Giftaway eGift (referred to as “Reward”) for every successful credit card referral (referred to as “Referral”) that gets approved within the promo period.
2. The Citibank Member-Get-Member Promotion (referred to as “Promo”) will run from July 23 to December 31, 2018 (the “Promo Period”).
3. The Promo is open to existing Principal Citi Cardholders of Citibank, N.A. Philippine Branch (referred herein as “Citibank”), whose cards accounts are active and in good credit standing who are not prohibited under the applicable Gifts, Anti-Bribery and Corruption laws, regulations and policies from participating in and /or qualifying for this Promo, and who receive the Electronic Direct Mail (EDM) or SMS referral invitation (referred to as “Referrer”). Citibank, N.A. Philippine employees, incumbent government officials or employees, whether elected or appointed, and US Persons are not eligible to participate in this Promo.
4. The Promo is not applicable to Referrers and Referrals if the Referral is a resident individual of the European Union, European Economic Area (EEA) or any other jurisdictions where referral activity is restricted. Please consult a bank representative for details.
5. To qualify for the Reward:
 - The Referrer needs to refer by going to the Citi ShareRewards page (<http://citibank.com.ph/refer>). He/she may also access the same via the Electronic Direct Mail (EDM) invite or SMS sent to him/her.
 - The Referrer must complete the 3-Steps Referral Process within the ShareRewards page:
 - i. Step 1 – Referrer needs to provide the last 6 digits of registered mobile phone number with Citi.
 - ii. Step 2 – Referrer needs to provide the last 4 digits of his/her Citi credit card.
 - iii. Step 3 – Referrer will get the unique referral link by clicking on the “Copy Link” button and needs to share this link on his/her social media accounts by clicking the Twitter, Facebook, or Email button from the page
 - The Referrer must refer prospects who meet the criteria set out in item 6.
 - The prospect referred by the Referrer (“Referral”) must apply for a Citi credit card during the Promo Period, using the unique referral link provided by the Referrer.
 - The Citi credit card application of the Referral must be approved.
6. The Referral must at a minimum meet the following criteria:
 - Has no Principal Citibank Credit Card or has not had one within the last 6 months prior to the referral.
 - Is between 21 to 65 years old
 - Has a gross annual income of at least P250,000.

7. The qualified Referrer will be able to redeem his/her Reward as follows:
- a. 20 business days after Referral's card application is approved, the qualified Referrer will receive an SMS that contains the following:
 - a. Redemption link: <http://gft.ph/citirefer>
 - b. Promo code
 - b. The qualified Referrer shall be entitled to redeem the Reward through Giftaway.ph after 3 business days from receipt of the SMS / EDM.
 - c. He/she should provide the following information to Giftaway.ph, the accredited redemption merchant, through the redemption link:
 - a. Promo code;
 - b. Name;
 - c. Email address;
 - d. Mobile number;
 - e. Last 6 digits of his/her Citi credit card.
 - d. By redeeming the Reward through the Giftaway redemption site, the Referrer is responsible for providing his/her personal and other information to Giftaway.ph, and agrees that such information, provided by the Referrer to Giftaway.ph, will be subject to the confidentiality, data privacy and security terms of Giftaway.
 - e. The Referrer will receive an eGift code through his/her nominated email address and mobile number.

9. The eGift code may be used to buy any item in the mentioned stores above or at any other Giftaway merchant.
10. The promo codes are valid (and the qualified Referrer may input the code in the redemption link) until:
- October 31, 2018 – for accounts that qualify within July 23-31, 2018;
 - November 31, 2018 – for accounts that qualify within August 1-31, 2018;
 - December 31, 2019 – for accounts that qualify within September 1-30, 2018;
 - January 31, 2019 – for accounts that qualify within October 1-31, 2018
 - February 28, 2019 – for accounts that qualify within November 1-30, 2018
 - March 31, 2019 – for accounts that qualify within December 1-31, 2018
- Promo codes which are not redeemed/consumed as of the above dates will be forfeited in favor of Citi.
