

PROMO MECHANICS/TERMS AND CONDITIONS – Citi’s LoveToClick Mother’s Day Promotions with Designer Blooms

 - j) When the popup disappears, click on PROCEED TO CHECKOUT again.
 - k) Complete Billing and Shipping details.
 - l) If you applied the coupon code without verifying your card, input the 1st six digits of your card in the ORDER DETAILS under the SHIPPING TAB of the checkout process.
 - m) Review your order.
 - n) Select PayPal or iPay88 as mode of payment.
 - o) Tick the checkbox, then click PROCEED TO PAYPAL (Paypal) or PLACE ORDER (iPay88).
 - p) For PayPal payments, enter your email or mobile number or click Pay with a Bank Account or Credit Card.
 - q) Input Credit Card details
 - r) For iPay88 payments, input your credit card details to proceed.
 - s) Order confirmation received and you will receive an email regarding your order soon.
5. Promo code can be availed by using the promo code **CITIDBMDAY**, For Multiple Use.
6. The Promo offer is valid only for delivery in Metro Manila and limited parts of Laguna and Cavite.
7. Discount is valid statewide and in-store.
