

PROMO MECHANICS/TERMS AND CONDITIONS – Citi’s LoveToClick Sale with HAVAIANAS

 - 4.9 Select preferred payment method, select/fill address and click complete order button
 - 4.10 Enter card details to complete order
 - 4.11 Submit OTP
 - 4.12 Once payment is confirmed, customer will receive a confirmation email and wait for order to arrive!
5. Promo code can be availed by using the promo code CITIHAVS+first 6 digits of Citi cards.
