

**Terms and Conditions**  
**Citi Cards Acquisition Special Welcome eGift July and August 2021 Promo**

1. The Citi Cards Acquisition Welcome eGift March 2021 Promo (“Promo”) will run from July 7, 2021 until August 31, 2021 (“Promo Period”).
2. The Promo is open to all Citi credit card applicants who:
  - a. Do not have an existing Principal credit card issued by Citibank, N.A. Philippine Branch (“Citibank” or “Citi”) and have not had one in the last six (6) months before application;
  - b. Apply for any of the following Cards within the Promo Period: Citi Prestige Card; Citi PremierMiles Card; Citi Rewards Card; Citi Cash Back Card; Shell Citi Card; Mercury Drug Citi Card, Grab Citi Card, Citi Simplicity+ Card (“Card”);
  - c. Are not prohibited under applicable Gifts, Anti-Bribery and Corruption laws, regulations, and policies from participating in or qualifying for this Promo; and
  - d. Receive an SMS, email, or applied through a specific application channel indicated in the promo communication regarding the Promo.Citi Credit card applicants who meet all of the criteria above are referred to as the “Applicant”.
3. An Applicant who applies via the specific application channel and within the specified application period indicated in the communication from Citi or Citi’s partners and who gets approved for a Citi credit card within the promo period shall be entitled to receive a P2,000 eGift.
4. The qualified Applicant will receive an SMS confirmation of his/her eligibility to receive the eGift fifteen (15) business days from completing his/her credit card application. The SMS will contain the eGift code/a client may present at any participating Giftaway merchant. Client may visit [citicardsacqui.giftaway.ph/universal/500](http://citicardsacqui.giftaway.ph/universal/500) for the list of participating Giftaway merchants he may redeem his eGift/s at.
5. The eGift/s will be in P500 denominations and are valid for 1 year after the qualified Applicant receives the eGift codes from Citi via SMS.
6. The Reward may not be converted to or paid out in cash or in kind.
7. Citibank may discontinue the granting of the Reward to the Applicant if applicable law, regulation, or policy restricts the continued granting of such Reward.
8. In case of dispute with respect to the Applicant’s eligibility, coverage of dates, fulfillment, etc., Citibank’s decision shall prevail. All questions or disputes regarding the Applicant’s eligibility for the Program shall be resolved by Citibank with concurrence of DTI.
9. Fraud, abuse or any unauthorized action relating to the credit card application, the participation in the Promo, may result in the disqualification of the Applicant from the Promo at Citibank’s discretion. This shall be without prejudice to any legal action that may be taken by Citibank.
