 - c. Full payment via payment link within the specified period is required to confirm booking, otherwise, the Hotel reserves the right to cancel booking.
 - d. Once full payment has been made, the hotel will send confirmation voucher via e-mail.
 - e. The confirmation voucher and the Citi Credit Card used must be presented upon check-in together with a government-issued ID of the cardholder to verify that the booking is qualified for the promo. In case that the guest is not the Citi cardholder, a photocopy of the Citi Card and government-issued ID of the cardholder may be presented. Should the guest fail to present, the current best rate will be applied and all the room inclusions under Citi Promo forfeited. Other resort policies and procedures apply.
